ROAD SAFETY AND PARKING PROMISE

EMAIL AND INTERNET POLICY

School rules for responsible internet use: (Pupils sign these on a separate agreement)

- I will ask permission before using the internet
- I will only look at or delete my own work
- I understand that I must not use my own software, CD's, hard drives or pen drives in school without permission
- I will only email people that I know or people that my teacher has approved
- All messages I send will polite and sensible following SMART rules
- I understand I must never give my home address, phone number or any personal details to anyone on the internet and I must never arrange to meet anyone over the internet
- I will ask permission before opening an email or an email attachment sent by someone I do not know
- If I see anything I am not happy with or receive messages I do not like, I will tell my teacher immediately
- I understand that the school may check my computer files and the internet sites I visit
- I understand that if I break these rules, I may be banned from the internet and use of iPads and Computers
- I understand children under the age of 13 should not be using social media platforms and these are not accessible through school
- I will only play age appropriate games and apps at home and I will not use internet chatrooms or apps that are not appropriate
- When using Microsoft Teams for online learning I understand that I have to respect others and follow the same behaviour and learning expectations as when I am in class
- I understand that everything that is written / recorded on Microsoft teams is seen by my class teacher and the Principal
